In reference 1 the Supply System provided the NRC with the management plan for the construction delay of WNP-1. Reference 2 submitted Revision 1 to the plan. By Reference 3, the NRC issued an order extending the WNP-1 construction completion date to June 1, 1991.

The Supply System continues to receive NRC Bulletins and Generic Letters that in many cases require an investigation of hardware and/or software and a response to the NRC. Since the Project has been placed in this extended construction delay and resources have been limited to only those necessary for preserving the assets, the Supply System, in most cases, has been sending letters to the NRC indicating that our response must be deferred until the resumption of construction activities. We believe that continuing to respond in this fashion is unnecessarily repetitious.
