STATEMENT OF QUALITY ASSURANCE POLICY

The Quality Assurance Program described herein has been developed by the Dairyland Power Cooperative to assure safe and reliable operation of LACBWR. This program is designed to meet the requirements of Title 10 of the Code of Federal Regulations, Part 50, Appendix B, "Quality Assurance Criteria for Nuclear Power Plants and Fuel Reprocessing Plants," as it would apply to a possession-only condition.

The Quality Assurance Program applies to all activities affecting the functions of the structures, systems, and components that are associated with a possession-only license. These activities include design, operations, maintenance, repair, fuel handling, testing, and modifications.

The DPC QA Director is responsible for the establishment of a Quality Assurance Program which meets the requirements of 10 CFR 50, Appendix B, and implementing the program.
