RESPONSE TO NOTICE OF VIOLATION VIOLATION NUMBER 50-395/88-11-01

I. ADMISSION OR DENIAL OF THE ALLEGED VIOLATION

South Carolina Electric & Gas Company (SCE&G) is in agreement with the alleged violation.

II. REASON FOR THE VIOLATION

The Nuclear Operations Department was reorganized in late January 1988, at which time several personnel were assigned new positions in the emergency response organization. Two of these individuals did not receive initial training prior to being assigned to their new positions.

III. CORRECTIVE STEP TAKEN AND RESULTS ACHIEVED

The subject individuals received the required training during the week of May 9, 1988, and demonstrated an acceptable knowledge level.

IV. CORRECTIVE ACTION TAKEN TO AVOID FURTHER VIOLATION

Due to the large reorganization effort, it is considered that this failure to schedule the training was an isolated incident since the remaining key personnel had received the required training. The Emergency Services Coordinator (ESC) is assigned the responsibility to ensure that when Emergency Planning training is required (i.e. reorganization, new employee, transfer of personnel, etc.), the designated personnel are scheduled for training, attend the session(s), and so ccessfully complete the training.

V. DATE OF FULL COMPLIANCE

SCE&G was in full compliance with respect to the stated corrective action as of May 13, 1988.
