Low-Level Waste

Inspection of Battelle Columbus Labs

On July 19, 1988, LeRoy Person will assist Region III in an inspection of Battelle Columbus Laboratories radwaste processing facilities. This inspection will examine the procedures used by Battelle for characterizing and classifying irradiated hardware in response to questions raised by the State of South Carolina. As the agreement state authority, South Carolina inspects packages sent to the Barnwell Disposal Site. Results of this inspection will be useful in developing further guidance on acceptable waste classification methods for reactor core hardware components.

Meeting With South Dakota Secretary of Water and Natural Resources

On July 12, 1988, M. Fliegel of NMSS, R. Fonner of OGC and C. Maupin of GPA met with John J. Smith, Secretary of the South Daketa Department of Water and Natural Resources. Mr. Smith discussed South Daketa's proposal to dispose of approximately 270,000 tons of sewage ash at TVA's Edgemont site, an NRC licensed mill in the process of being decommissioned. Mr. Smith had written to Chairman Zech on June 14, requesting that NRC allow this disposal. NRC staff told Mr. Smith that a response to his letter was being finalized and that it would state that in order for NRC to consider such a proposal, the request must come from our licensee. TVA.
