The proposed revision to Section 6.0 (Attachment I) reflects two organizational title changes which have been previously discussed with the staff. This revision also includes an updated Page 6-5 (Attachment III) related to the July 6, 1987 submittal for which the Safety Hazards Consideration does not change.

Attachment I provides the Safety Hazards Consideration pursuant to 10CFR50.91(a)(1). This request has been reviewed and approved by the Plant Safety Review Committee and the Nuclear Safety Review Committee. SAFETY HAZARDS CONSIDERATION

The Commission has provided standards in 10CFR50.92(c) for determining whether a significant hazards consideration exists. A proposed amendment to an operating license for a facility involves no significant hazards consideration, if operation of the facility in accordance with the proposed amendment would not: (1) involve a significant increase in the probability or consequences of an accident previously evaluated; or (2) create the possibility of a new or different kind of accident from any accident previously evaluated; or (3) involve a significant reduction in a margin of safety.

1. The proposed amendment does not involve a significant increase in the probability or consequences of an accident previously evaluated because the organizational title changes do not affect plant operation in any manner.
2. The proposed amendment does not create the possibility of a new or different kind of accident than previously evaluated because the proposed changes are administrative in nature and do not affect organizational responsibilities. Also, no physical alterations of plant configuration or changes to setpoints or operating parameters are proposed.
3. The proposed amendment does not involve a significant reduction in a margin of safety. Through SCE&G's Quality Assurance programs and efforts to maintain only the most qualified personnel in positions of responsibility, it is assured that safety functions performed by personnel within the Nuclear Operations Division will continue to be performed at a high level of competence.

Based on the above reasoning, SCE&G has determined that the proposed amendment does not involve a significant hazards consideration.
