This refers to the routine safety inspection conducted by Mrs. T. H. Darden and Mr. L. M. Tripp of this office on December 13, 1985 of activities authorized by NRC License No. 37-21345-01MD and to the discussions of our findings held by Mrs. Darden with yourself at the conclusion of the inspection.

The inspection was an examination of activities conducted under your license as they relate to radiation safety and to compliance with the Commission's rules and regulations and the conditions of your license. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violations brought to your attention in a letter dated March 6, 1985. We have no further questions regarding your action at this time.

Item A described in the attached Notice of Violation, involving control of licensed material, is classified as a Severity Level IV violation. As indicated in Supplement IV of the NRC Enforcement Policy significant violations of this type are normally classified as Severity Level III. However, after careful consideration of the factors involved in this specific instance, including the fact that the impact on the health and safety of the public was minimal and remote since removal of the unsecured material was unlikely, we have exercised our judgement under the NRC Enforcement Policy and have classified this violation as a Severity Level IV. Similar violations of this type in the future may result in additional enforcement action.



a. Instructions on notification of appropriate personnel within your organization.
