SUBJECT: CRGR MEETING NO. 144, REVISION 1

The Committee to Review Generic Requirements (CRGR) will meet in the afternoon on Wednesday, August 10, 1988 in Room MNBB 6507. The agenda is as follows:

- 1-2 p.m. G. Arlotto (RES) will present for CRGR review the proposed final Reg. Guide, "Qualification of Safety-Related Lead Storage Batteries for Nuclear Power Plants." (The review package is enclosed.)
- 2-3 p.m. W. Houston (RES) will present for CRGR review a proposed Rev. 3 to Reg. Guide 1.9, "Selection, Design, Qualification, Testing, and Reliability of Diesel Generator Units Used as Onsite Electric Power Systems at Nuclear Power Plants" (relating to the resolution of Generic Safety Issue B-56). (The review package is enclosed.)
- 3-4 p.m. L. Shao (NRR) will present for CRGR review a proposed NRC staff SER on generic BWR Emergency Procedure Guidelines. (The review package is enclosed.)

If a CRGR member cannot attend the meeting, it is his responsibility to assure that an alternate, who is approved by the CRGR Chairman, attends the meeting.

Persons making presentations to the CRGR are responsible for (1) assuring that the information required for CRGR review is provided to the Committee (CRGR Charter - IV.B), (2) coordinating and presenting views of other offices, (3) as appropriate, assuring that other offices are represented during the presentation, and (4) assuring that agenda modifications are coordinated with the CRGR contact (J. Conran X29855) and others involved with the presentation. Division Directors or higher management should attend meetings addressing agenda items under their purview.

In accordance with the EDO's March 29, 1984 memorandum to the Commission concerning "Forwarding of CRGR Documents to the Public Document Room (PDR)," the review packages for items scheduled at this meeting, which contain
