## Dear Mr. Lopez:

I am responding to your August 10, 1998, letter concerning annual fee Invoice No. AM4320-98 for License No. 52-19702-01. Your letter states that: (1) on February 4, 1998, you requested termination of your license; (2) you received termination documents dated May 20, 1998; and (3) Invoice No. AM4320-98 dated July 11, 1998, is not applicable. Our records show that License 52-19702-01 was terminated on May 20, 1998, in accordance with your letter dated February 4, 1998. For the reasons explained below, your termination request was timely tiled for purposes of the 50 percent proration and Invoice No. AM4320-98 is due and payable.

Footnote 1 of 10 CFR 171.16 provides that the annual fee is waived when a license is terminated prior to October 1 of each fiscal year. The 1998 annual fee is waived for licensees and holders of certificates, registrations, and approvals who either filed for termination of their license or approvals or permanently ceased licensed activities by September 30, 1997. An amendment request filed after October 1 of each year to cancel a license does not cancel the annual fee invoice. Your February 4, 1998, request was not timely filed for the purposes of avoiding the FY 1998 annual fee.

As provided in 10 CFR 171.17, licenses for which termination requests are filed during the period October 1 through March 31 for the fiscal year are assessed one-half of the annual fee. Your February 4, 1998, termination request was timely filed for purposes of the 50 percent proration. Therefore, Invoice No. AM4320-98 is correct as it reflects the 50 percent proration. Payment should be sent to the address listed on the invoice.
