The purpose of this modification is to provide incremental funding in the amount of \$48,000, thereby increasing the obligated amount from \$3,236,815 to \$3,284,815.

Accordingly, the following change is hereby made:

Under Section B - Supplies or Services and Prices/Costs, Paragraph B.4 - Consideration and Obligation--Delivery Orders, the first sentence of Subparagraph (b) is hereby deleted in its entirety and substituted in lieu thereof the following:

"B.4 - CONSIDERATION AND OBLIGATION

(b) The amount presently obligated with respect to this contract is \$3,284,815."
