MEMORANDUM AND ORDER
(Extension of Stay; Telephone Conference)

SERVED SEP 23 1998

On Wednesday, September 23, 1998, the Atomic Safety and Licensing Board conducted a telephone conference, to discuss the progress of ongoing settlement negotiations between the parties. The conference was noticed by the Licensing Board's Memorandum and Order (Stay of Proceeding and Telephone Conference) dated August 18, 1998. Participating, in addition to the three Licensing Board Administrative Judges, were Ann P. Hodgdon, Esq., Catherine L. Marco, Esq. and Stephanie Martz, Esq., for the NRC Staff; and Thomas H. Lee, II, Esq. for Dr. Magdy Elamir.

Mr. Lee reported that the two parties were close to reaching a settlement agreement but that, with respect to one element of the proposed settlement (not further identified), there was no agreement. Mr. Lee asserted, with respect to that item, that Dr. Elamir had made a reasonable

offer but the NRC Staff was unwilling to compromise. Ms. Hodgdon asserted, with respect to that item, that the Staff was not unwilling to compromise but had not received an offer upon which a compromise could be considered.

Both parties acknowledged that the matter in dispute was not based on a factual dispute but only upon a difference of opinion as to what was reasonable. The Board advanced two possibilities for the parties to consider:

1. Appointment of a Settlement Judge or Special Master (acting as a Mediator) to make a recommendation for Board approval; or

2. Stipulate as many facts as possible and go to hearing only on the narrow issue in dispute.

Ms. Hodgdon advised that she had not been authorized by her client (the Director, OE) to entertain the first option, and she asked for additional time to consult with OE. The parties agreed to permit Ms. Hodgdon to consult with OE and to report to the Board and Mr. Lee in a conference call (initiated by the Board) on Monday, September 28, 1998, beginning at 10:00 a.m. The stay is extended until then.
