Summary of Changes For Emergency Plan ICN 18-2

The STP Emergency Plan change is as follows:

Section G, Table G-3, Page 1 of 4	Emergency Response Facilities Data Acquisition and Display System Added information to describe Integrated Computer modification.

Reason for Change: The Emergency Plan change is being made to support the Integrated Computer System modification (ICS). The purpose of the ICS project is to replace the Emergency Response Facilities Data Acquisition and Display System (ERFDADS) due to the improved technology available. None of the capabilities for the required Emergency Planning computer systems SPDS and ERDS will be affected by the project, (see USQE 97-0049). All the points and required displays that were available before the modification will be available after the modification is completed. The Emergency Response Organizations' ability to perform accident analysis and support of mitigation will not be impacted during installation or after since all the same information with the same reliability will be available throughout.
