The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors.

During this inspection, it was found that certain of your activities appeared to be in violation of NRC requirements. This apparent violation is being reviewed for appropriate enforcement action. An enforcement conference to discuss this item will be scheduled. Following the enforcement conference you will be notified of the resolution of these findings.
