Dear Administrative Judges:

Reference is made to the discussion at pages 17-29 of the transcript of the Special Prehearing Conference held in these proceedings in Knoxville, Tennessee on July 21, 1988. In part, the discussion focused on the necessity or desirability of the Board, pursuant to 10 C.F.R. § 2.904, designating a representative to advise and assist the Board and parties, if necessary, with respect to security classification of information and the safeguards to be observed with regard to such information. Staff suggested utilizing, if necessary, an "independent reviewer" from the Commission's Office of Security (i.e., someone who has not reviewed or supervised the security/safeguard reviews of the AlchemIE applications). Applicant indicated it had no objection to using an "independent reviewer" from Staff. (Tr. 29).


Richard A. Dopp (Primary Advisor)
