On August 17, 1995, the NRC issued Generic Letter (GL) 95-07, "Pressure Locking and Thermal Binding of Safety-Related Power-Operated Gate Valves," to request that licensees take actions to ensure that safety-related power-operated gate valves that are susceptible to pressure locking or thermal binding are capable of performing their safety functions.

By letter of February 13, 1996, Commonwealth Edison Company (ComEd) submitted its 180-day response to GL 95-07 for Dresden, Units 2 and 3. The NRC staff reviewed ComEd's submittal and issued a request for additional information (RAI) on April 2, 1996. By letter of May 24, 1996, ComEd provided the additional information. On June 5, 1996, the NRC issued a second RAI and on July 5, 1996, ComEd provided the additional information. The NRC issued a third RAI on May 28, 1997, and in a letter of May 29, 1998, ComEd provided the additional information. The NRC staff performed an inspection to review specific aspects of information summarized in ComEd's responses to GL 95-07. This inspection is documented in NRC Inspection Report 50-237/249-96015, dated February 14, 1997.

The NRC staff has reviewed ComEd's submittals and finds that ComEd has adequately addressed the actions requested in GL 95-07, as discussed in the enclosed safety evaluation. This completes our efforts under TAC Nos. M93458 and M93459.
