This refers to the routine unannounced radiation safety inspection conducted by Messrs. P.J. Garcia and V.R. Scovill of this office on April 11-13, 1988, of the activities authorized by NRC Source Material License SUA-1358 and to the discussion of the findings held by the inspectors with members of your staff at the conclusion of the inspection. During this inspection, certain of your activities were found not to be conducted in full compliance with NRC requirements. Consequently, you are required to respond to this matter in writing in accordance with the provisions of Section 2.201 of the NRC "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

The inspectors also reviewed the corrective action you had taken with respect to the violations identified during an inspection conducted March 16-18, 1987. They verified that the corrective actions with
