Within these areas, the inspection - resisted of selective examinations of records and observations by the inspector.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC to wirements, as set forth in the Notice of Violation enclosed as Appendix A to val letter. The items have been categorized into a severity level as described in the NRC Enforcement Policy, 10 CFR Part 2, Appendix C.

Your response to this Notice is to be submitted in accordance with the provisions of 10 CFR 2.201 as stated in Appendix A, Notice of Violation.

In accordance with Section 2.790(d) of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, documentation of the findings of your control and accounting procedures for safeguarding special nuclear material are exempt from public disclosure; therefore, the enclosed inspection report, the enclosed notice of violation and your response thereto will not be placed in the Public Document Room.

The responses directed by this letter and the enclosed Notice are not subject TEOD to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
