Dear Dr. Murley:

Reference 1 discussed failures of General Electric Type HFA relays and required replacement of the affected relay coils by March 12, 1986.

Reference 2 identified 285 relays requiring modification or replacement. Completion of the replacement program was scheduled for January 31, 1986. However, because a scheduled outage was postponed, the replacement program was not completed by that date. Currently, 26 of the 285 relays remain to be replaced.

The next outage is scheduled to begin on March 14, 1986. The relays are scheduled to be replaced at that time.
