## FORUM NEWS

Meeting Correction At the LLW Forum's July meeting, NRC reported that a completeness determination for a low-level radioactive waste disposal facility application would be made within 45 days of the application's submission. According to NRC policy, the completeness determination will be made within 30 days after an application has been tendered. The administrative process for conducting the completeness determination is outlined in 10 CFR 2.101(a)(2). Further guidance on NRC's license review procedures may be found in NUREG-1274, "Review Process for Low-Level Radioactive Waste Disposal License Application Under the Low-Level Radioactive Waste Policy Amendments Act."

Public Participation Workshop Tentatively Scheduled for November 17-18. A workshop on public participation for Forum Participants and state and compact officials responsible for developing and implementing public involvement programs has been tentatively scheduled for November 17-18, 1988 in Washington, D.C. Forum Participants should check these dates and notify Afton Associates immediately if there are potential conflicts with the proposed dates.

Afton staff will be working with selected Forum Participants and compact and state officials to plan the workshop's final format and content. The purpose of the workshop is to allow individuals responsible for public participation programs to engage in a constructive dialog about various public participation and information techniques and to share information and experiences with experts in the field. The workshop will provide basic information about public participation and information strategies and will focus on state experiences in working with the public to sie LLW disposal facilities. Outside resource persons will also be invited to participate and respond to various problems and questions posed by the workshop participants.

The final schedule for the workshop and other preparatory materials will be distributed prior to the Forum's October meeting. Mixed Waste Report Afton Associates has finalized the document, Assessment of Mixed Waste Management Issues and Federal Guidance, which was distributed prior to the Forum's July meeting. The assessment is based on extensive discussions with state officials responsible for developing and regulating low-level radioactive waste disposal facilities, including mixed waste disposal units. The minor revisions incorporated in the final version reflect comments received from federal and state officials.

NRC's Division of LLW Management and Decommissioning has also provided a preliminary and somewhat abbreviated response to the draft report explaining NRC's present approach to mixed waste and its immediate future plans regarding guidance on mixed waste. NRC will notify the Forum of any additional NRC activities concerning mixed waste guidance or other developments.

EPA also hopes to provide a similar response and update prior to the Foruni's next meeting. Officials from both NRC and EPA will discuss mixed waste at the Forum's October meeting.

## Proposed Dates Set For 1989 Forum Meetings

The 1989 LLW Forum Calendar includes tentative dates for the 1989 Forum meetings. Forum Participants should review the proposed dates for potential conflicts. Participants are asked to contact Afton Associates regarding any conflicts with the proposed dates or to make other suggestions for the meeting dates.

## RECENT DEVELOPMENTS FEDERAL AGENCIES

## Department of Energy

DOE Developing <u>Federal Register</u> Notice on 1990 Milestone The Department of Energy is currently working on a <u>Federal Register</u> notice concerning surcharge eligibility determinations based on compliance with the 1990 milestone. DOE hopes to publish the notice by the end of this year and plans to send a letter with the notice as an attachment to the governors of all unaffiliated states and all states in unsited compacts in early 1989.

## Nuclear Regulatory Commission

NRC Developing 1990 Milestone Guidance The Nuclear Regulatory Commission has distributed a letter outlining NRC's guidance on the 1990 milestone to state liaison officers and other state and compact officials. The letter was originally sent to Teri Vierima, Chair of the Midwest Compact Commission, by Hugh Thompson, Director of Nuclear Materials Safety and Safeguards. It describes in general terms the suggested content of governor's certifications to be submitted by the governors of all unaffiliated states and states in unsited compact regions in response to the 1990 milestone. In the cover memo distributed with the Vierima letter, NRC requested that comments on the suggested guidance be forwarded to Carlton Kammerer, Director of State, Local and Indian Tribe Programs, by September 16, 1988. NRC staff is internally reviewing options for implementing the agency's responsibilities under the Low-Level Radioactive Waste Policy Amendments Act concerning the 1990 milestone and developing the final guidance necessary to assist the states in preparing governor's certification documents.

Advisory Committee on Nuclear Waste (ACNW) Meets The NRC's ACNW met on September 13-14 to discuss proposed regulatory responsibilities for mixed waste, LLW handling processes, high-density polyethylene high-integrity containers, concrete waste forms and the NRC's BRC policy. Mal Knapp, Director of the Division of LLW and Decommissioning, briefed the ACNW on the Division's plans for fiscal year 1989.

Comment Period on NRC's High-Level Waste/Greater-Than-Class C Waste Rulemaking Not Extended The NRC has decided not to extend the comment period on its proposed amendments to 10 CFR Part 61 concerning the disposal of greater-than-Class C waste even though some state states and the Department of Energy had inquired about an extension several times in the past. On occasion, NRC has considered late comments if they are received prior to development of the final rule.

#### CONGRESS

### House of Representatives

Representative Udall Introduces Southwestern Compact Legislation On August 11, Rep. Morris Udall introduced legislation (H.R. 5232) to grant Congressional consent to the Southwestern Compact. The bill was jointly referred to the House Committees on Energy and Commerce and Interior and Insular Affairs. Rep. Udall's Subcommittee on Energy and the Environment conducted a hearing and mark-up session on H.R. 5232 on September 8. Charles Tedford, Director of the Arizona Radiation Regulatory Agency, and James Morgan, Deputy Secretary for Legislative and Public Affairs of the California Health and Welfare Agency testified in support of Congressional consent to the Compact. Following the Subcommittee mark-up, the bill was referred to the full Committee on Interior and Insular Affairs for consideration.

## RECENT DEVELOPMENTS STATES AND COMPACTS

### Central Midwest/Illinois

IDNS Selects Two Additional Sites for Characterization On August 22, the Illinois Department of Nuclear Safety announced the selection of two additional alternative locations for investigation as possible sites for a low-level radioactive waste disposal facility. Both sites are in counties where alternative sites, selected earlier this year, are currently undergoing site characterization. One of the newly announced alternative sites is located in Clark County south of the City of Martinsville, and the other is located in the western half of Wayne County. IDNS identified these two sites based on preliminary indications that the sites would meet the technical requirements for establishing a low-level radioactive waste disposal facility in Illinois.

## Midwest/Michigan

Michigan LLW Authority Approves Proposal to Develop Low-Level Radioactive Waste Research and Educational Institute On August 25, the Michigan LLW Authority approved a proposal from Michigan State University and the University of Michigan which allows the universities to assist the state and local communities in researching questions regarding low-level radioactive waste management. Once organized, the Michigan Low-level Radioactive Waste Research and Education Institute will have branches located in East Lansing and Ann Arbor. After establishment of the disposal facility, the Institute will be relocated in the host community. The Institute will initially be funded through preoperational monies provided by the compact. Once the disposal facility is operational, funds for operating the Institute will be provided by disposal fees. The focus of the institute will be on research and public education by specialists in various areas related to waste management, facility design and construction and employee training.

Compact Commission Adopts Radium-226 Resolution At its annual meeting, the Midwest Compact Commission adopted a resolution requesting its member states to ask users of radium-226 sources to substitute alternative radioactive materials for the radium sources. This action was the result of the State of Michigan's decision not to accept radium-226 waste for disposal at the Compact's regional disposal facility.

### New York

DEC Issues Final Regulations on LLW Transportation The New York Department of Environmental Conservation (DEC) has issued final regulations for transporters of low-level radioactive waste as well as manifest requirements for shipping such waste. The regulations are supported by a two-volume environmental impact statement and detailed risk assessment document.

The final EIS, including the risk assessment document, should be available from DEC next month. The regulations require transporters of low-level radioactive waste to obtain a permit for each trailer used to haul such waste into, within or through New York and requires that each shipment of waste be accompanied by a state manifest form. The regulations also require each truck hauling low-level radioactive waste to carry insurance in the amount of \$5 million for a large truck and \$1 million for a small truck. New York adopted these new regulations to comply with the requirements of 10 CFR Part 61 and Part 20.311.

#### Northwest

Northwest Compact Commission Approves Contract With North Dakota At its August 23, meeting the Northwest Compact Commission approved a contract to dispose of North Dakota's low-level radioactive waste until December 31, 1990. The contract has been sent to North Dakota for the Governor's approval.

#### Southeast/North Carolina

North Carolina Low-Level Radioactive Waste Management Authority Appoints Proposal Review Committee The North Carolina LLW Management Authority has received proposals for a facility developer/operator from Chem-Nuclear Systems and Westinghouse. The Authority has appointed a proposal review committee consisting of four members of the Authority, a generator of low-level radioactive waste, a representative of an industry that does not generate low-level radioactive waste, a local government representative and two representatives from public interest groups. The committee will review the two proposals and make a recommendation to the Authority. The Authority also plans to sponsor several public meetings around the state for Chem-Nuclear and Westinghouse to explain their proposals and answer questions.

#### Southwestern/California

Mixed Waste Workshop Scheduled to Discuss Options The State of California is sponsoring a mixed waste workshop in Sacramento on October 12-13 to discuss options for managing mixed waste in the Southwestern Compact. The workshop will review basic information on mixed waste and will include perspectives on mixed waste management and regulation from federal, state and industry officials as well as environmental and local interests. Discussion at the workshop will focus on options for managing mixed waste in the Southwestern Compact region. ## South Carolina/Nevada/Washington

Sited States Reviewing Criteria for 1990 Milestone The three sited states are reviewing criteria for determining compliance with the 1990 milestone. The criteria will provide guidance to the unaffiliated states and states in unsited compact regions planning to submit governor's certifications to meet the milestone. Sited states will be prepared to discuss the 1990 criteria at the Forum's October meeting.
