SUBJECT: ENFORCEMENT CONFERENCE SUMMARY
(NRC INSPECTION REPORT NOS. 50-335/88-20 AND 50-389/88-20)

This letter refers to the Enforcement Conference held at our request on September 6, 1988. This meeting concerned activities authorized for your St. Lucie facility. The issues discussed at this conference related to the inattentiveness of a guard posted to control access to a vital area and the failure to report this event in a timely fashion. A list of attendees, a summary, and a copy of your handout are enclosed. We are continuing our review of these issues to determine the appropriate enforcement action.

In accordance with 10 CFR 2.790(d) and 10 CFR 73.21, safeguards activities and security measures are exempt from public disclosure. Therefore, the enclosures to this letter will not be placed in the NRC Public Document Room.
