Northeast Nuclear Energy Company (NNECO) hereby submits, as Attachment 1, Addendum 1 to Revision 11 to the FSAR in the form of replacement pages as required. Revision 11 to the FSAR was submitted on June 30, 1998.⁽¹⁾

Pursuant to 10CFR50.71(e)(2)(i), I certify that this revision accurately presents changes completed since our previous submittal that are necessary to reflect information and analyses submitted to the Commission or prepared pursuant to Commission requirements, as of December 31, 1997. NNECO has performed an extensive review of the Millstone Unit No. 3 design and licensing bases. The changes resulting from that review and presented herein represent those initiated through restart, June 30, 1998, except for one change which is pending completion of review.

For planning purposes and to enable orderly review by the Commission of the remaining changes to the FSAR resulting from the reviews, and as indicated in the letter submitted March 31, 1998,⁽²⁾ NNECO intends to submit periodic addendums to FSAR Revision 11, on an approximate quarterly frequency until the Unit 3 FSAR reflects information current to the date the unit was restarted. Subsequent to that,

revisions to the Unit 3 FSAR will be submitted in accordance with the schedule provided in 10CFR50.71(e).


