In the September 1985 Progress Review Meeting on Licensing Actions (meeting summary dated November 15, 1985) the staff discussed the status of your Emergency Response Facilities (ERF) (i.e., Technical Support Center, Operational Support Center and Emergency Operations Center) and Meteorological Data Upgrade. These are TMI Action Items III.A.1.2 and III.A.2.2, respectively, of the TMI Action Plan, NUREG-0737.

The staff was informed that these TMI Items are complete except for the deferment on the Safety Parameter Display System presented in your letter of July 26, 1985. The staff's decision on this deferment will be part of the separate action.

The requirements for the ERF and the Meteorological Data Upgrade are in Supplement 1 to NUREG-0737 dated December 17, 1982, and in NUREG-0654, respectively. The schedule to complete these items is in Confirmatory Order dated June 12, 1984. For these items, you were within the schedules in the Confirmatory Order although the staff must revise the schedule for the SPDS to be fully operational in the Confirmatory Order if it grants your requested SPDS deferment. The ERF and the Meteorological Data Upgrade will be audited against the staff's requirements by NRC Region I in an ERF Appraisal. This will be arranged by Region I.
