- 1. The licensee requests to name Ms. Angela Cloutier as an authorized user for all licensed listed in the license. Based on the information provided, it appears that Ms. Cloutier has been trained with some sealed sources during emergency preparedness exercises involving radioactive materials. If the licensee would like to name her as a user for sealed sources listed in the license for the authorized purpose of teaching and training of first responders and emergency personnel, please state. If not, provide information that she has been trained with the use of other unsealed radioactive materials authorized in the license. In addition, please provide a copy of her training completion certificate for the radiation safety training course she received from IUPUI as stated in page 7 of the amendment request and the course agenda.
- 2. The licensee requests to name Mr. Robert Brown as an authorized user for all licensed listed in the license. Based on the information provided, it appears that Mr. Brown has been trained with some sealed sources during emergency preparedness exercises involving radioactive materials. If the licensee would like to name him as the user for sealed sources listed in the license for the authorized purpose of teaching and training of first responders and emergency personnel, please state. If not, provide information that he has been trained with the use of other unsealed radioactive material authorized in the license.
- 3. The licensee requests to name Mr. Michael Kohlmann as an authorized user for all licensed listed in the license. Based on the limited training (4 hours training in basic radiation safety principle) and experience (working with thorium-230, strontium-90, carbon-14, hydrogen-3), Mr. Kohlmann does not meet the criteria listed in Section 8.7.2 in NUREG-1556, Volume 7, Revision 1. Please review NUREG-1556, Volume 7, Revision 1 and provide additional information as needed.
