Provided for your review and information is the FEMA notification and the completed assessment by FEMA Region VII for the local communities within the 10-mile Emergency Planning Zone (EPZ) of the Duane Arnold Energy Center and Quad Cities Generating Station (Iowa portion of EPZ).

The Region has concluded that offsite radiological emergency preparedness remains adequate to provide a Reasonable Assurance determination and that appropriate measures can be taken to protect the health and safety of the public in the event of a radiological emergency. In accordance with our memorandum, Subject: FEMA Preparedness Assessment Framework – COVID-19, dated May 13, 2020, as the emergency situation continues, THD in coordination with the regions, will continue to assess the offsite emergency preparedness capabilities within emergency planning zone and report accordingly.
