CALLAWAY PLANT RADIOLOGICAL EMERGENCY RESPONSE PLAN
CHANGE NOTICES 88-01, 88-02 and 88-03

Change Notices 88-01, 88-02 and 88-03 to the Callaway Plant Radiological Emergency Response Plan (RERP) have been issued to the controlled manuals which NRC has on file. These have been approved and implemented in accordance with Callaway Plant procedures and 10CFR50.54 (g).

Change Notice 88-01 incorporates Callaway Modification Package 84-0763A which extends the range of SJ-RE 01 (CVCS Letdown Monitor).

Change Notice 88-02 removes the reference to fire protection technical specifications from the Emergency Action Levels (EALs) and inserts references to APA-ZZ-00703, Fire Protection Operability Criteria and Surveillance Requirements.


Change Notice 88-03 changes the minimum value of AFW/MFW flow from 260,000 lb/hr to 300,000 lb/hr as established in plant emergency operating procedures. This minimum flow is used as indication for emergency classifications in the Emergency Action Levels.
