This is in reference to your telephone call to Gary Sanborn of my staff on August 12, 1998, in response to the letter and Notice of Violation sent to you on July 22, 1998. Although the letter transmitting the Notice of Violation stated that no response was required, you requested a clarification because the enclosed Notice of Violation stated that you were required to submit a written response.

The letter was correct. You are not required to submit a response unless you choose to do so, as indicated in the July 22 letter. I am sending you a corrected Notice of Violation to make it consistent with our letter and to make it clear to you that you are not required to submit a response.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, records or documents compiled for enforcement purposes are placed in the NRC Public Document Room (PDR). A copy of this letter with your address removed, and any response you choose to submit will be placed in the PDR after 45 days unless your response provides a basis for the NRC to withdraw this action. In addition, the NRC will provide a copy of this action to Entergy Operations, Inc.
