This letter refers to the routine safety inspection conducted by Mr. R. A. McBrearty of this office on April 18-22, 1988 at the Limerick Generating Station, Unit 2. Mr. McBrearty discussed the findings of the inspection with Mr. J. Corcoran at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of preservice inspection procedures and representative records, interviews with personnel, and observations by the inspector. The inspector discussed potential enhancements to your visual inspector certification program by using flawed samples. We understand that you are taking this recommendation under consideration.

Within the scope of this inspection, no violations were observed.


