
Dear Lt. Colonel Jordan:

On September 16, 1998, the NRC conducted an inspection at Pope Air Force Base (AFB), North Carolina. An exit briefing was conducted with the staff at Pope AFB at the completion of the inspection.

The purpose of the inspection was to determine whether activities authorized by Air Force Permit Numbers NC-10141-00/00AFP and NC-30202-01/00AFP were conducted safely and in accordance with NRC requirements. The inspection determined that an appropriate level of oversight had been provided for permitted activities and that activities had been conducted in accordance with NRC requirements and the conditions of the permits. Within the scope of this inspection no violations or deviations were identified; therefore, no response to this letter is required.
