This letter provides Gulf States Utilities Company's (GSU) initial response to NRC Bulletin 85-03, Supplement 1 "Motor-Operated Valve Common Mode Failures During Plant Transients Due to Improper Switch Settings".

The BWR Owner's Group (BWROG), of which GSU is a member, is developing a generic BWR position for meeting the requirements of this supplement.
