SUBJECT: INADEQUATE CORE COOLING INSTRUMENTATION SITE INSPECTION

The staff has reviewed your responses and would like to arrange a site verification inspection of the inadequate core cooling instrumentation (reactor vessel water level control and subcooling margin monitor) at the Point Beach Nuclear Plant. The inspection should last 1½ to 2 days and will review such things as operating procedures, training, calibration records and startup test data. The staff is available at anytime over the next three months except for the last week in March.
