South Carolina Electric & Gas Company (SCE&G), acting for itself and as agent for South Carolina Public Service Authority, submits six (6) copies of Amendment 13 to the Physical Security Plan, five (5) copies of Amendment 4 to the Safeguards Contingency Plan, and (5) copies of Amendment 4 to the Training and Qualifications Plan under the provision of 10CFR50.54 (p). These changes do not decrease the safeguards effectiveness of the Physical Security Plan.

These amendments reflect the changes to the Security Organization as a result of a January 1986 reorganization in SCE&G, which include re-assignment of two positions and re-assignment of responsibilities.
