This refers to the Preoperational Security Program Review conducted by Mr. R. J. Bailey of this office on January 13-16, 1986 at the Seabrook Nuclear Station, Seabrook, New Hampshire of activities authorized by NRC License No. CPPR-135 and to the discussions of our findings held by Mr. Bailey with Mr. Tuberty of your staff at the conclusion of the review.

Areas examined during this review are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the review consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.
