Subject: ENFORCEMENT CONFERENCE

Gentlemen:

During the period May 4th through September 2nd, 1988, the NRC conducted inspections at the Davis-Besse Nuclear Power Plant, Unit 1, to review an allegation concerning employment discrimination against a Quality Control Inspector for raising safety concerns. The results of these inspections are described in regional inspection report 50-346/88027 sent to you on September 12, 1988. The report also describes a potential violation of 10 CFR 50.7.

The NRC is considering this violation for potential escalated enforcement action and has scheduled an enforcement conference with you for 10:00 a.m. (CDT) September 26, 1988 in Region III. At the enforcement conference, you should be prepared to discuss (1) the safety significance of the potential violation, (2) the specific and underlying cause(s) of the potential violation, and (3) the actions taken or planned to correct the potential violation. We request that at the enforcement conference you provide a handout that succinctly describes your position concerning these enforcement considerations.
