SUBJECT: SUMMARY OF MEETING WITH SOUTH CAROLINA ELECTRIC & GAS COMPANY

General

On September 21, 1988, the NRC staff met with the South Carolina Electric & Gas Company (SCE&G) and their consultant to discuss the proposed change to Technical Specification (TS) 3.6.1.6, "Containment Structural Integrity," for the V. C. Summer Station. The meeting was held at Headquarters in Rockville, Maryland. A list of those persons who attended the meeting is included as Enclosure 1.

Discussion

The purpose of the meeting was to discuss the NRC's concern on removal of the Technical Specification Tables 4.6-la, 4.6-lb, and 4.6-2, without providing information on the tendons to be inspected in subsequent surveillances and the acceptable base value forces associated with those tendons. These tables address the tendons which were inspected during the first three surveillance periods. They depict the tendons inspected and the acceptable base value of tendon forces. The tendons which are to be inspected in subsequent inspections are detailed in an SCE&G document entitled, "Surveillance of Reactor Building Post Tensioning System," Revision 7, dated July 15, 1988. The acceptable tendon forces for each of the tandons to be inspected in subsequent surveillance is included in a figure in this document as are the normalizing factors. Discussion focused on the referencing of this report in the Bases of the Technical Specifications with allowance of a tendon to be changed if it was found impossible to test as a result of physical interference.
