Pursuant to 10 CFR 50.90, Florida Power & Light Company (FPL) submits herewith a request to amend Facility Operating Licenses DPR-67 and NPF-16 for St. Lucie Units 1 and 2, respectively.

These amendments are submitted to make changes to the St. Lucie Units 1 and 2 Physical Security Plan (PSP). By letter dated September 9, 1987, (H.N. Berkow to C. O. Woody), the NRC notified FPL that any change to the PSP which downgrades vital equipment requires a license amendment under the provisions of 10CFR50.90.

Attachment 1 to this letter is the proposed Physical Security Plan change. Attachment 2 is a Safety Analysis in support of the proposed amendment. Attachment 3 is a "Determination of No Significant Hazards Consideration".

The proposed amendment has been reviewed by the St. Lucie Facility Review Group and the Florida Power & Light Company Nuclear Review Board.


