SUBJECT: DOCKET NOS. 50-335 AND 50-389

This acknowledges the receipt of your letter of August 17, 1988, which transmitted Revision 16 to the St. Lucie Physical Security Plan.

Our review of the changes has found them to be consistent with the provisions of 10 CFR 50.54(p). Accordingly, they are acceptable for inclusion into the plan.

One change is not consistent with the provisions of 10 CFR 50.54(p) as delineated in the enclosure to this letter. Those changes in Appendix C regarding protection at the intake structure are being referred to the Office of Nuclear Reactor Regulation (NRR) for review and disposition. You will be advised by separate correspondence from NRR of their findings. Our concerns were discussed on September 12 and 16, 1988, with Mr. G. Madden of your staff and Ms. C. Perny of this office.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the enclosure will not be placed in the Public Document Room.

The enclosure to your letter is being withheld from public disclosure because it contains Safeguards Information and must be protected in accordance with the provisions of 10 CFR Part 73.21.
