This is a "Freedom of Information Act" request pursuant to 5 U.S.C. Sec. 552, et seq. and 10 C.F.R., Part 9, Subpart A.

Please send copies of all information (including but not limited to: letters and telecon messages from Gulf States Company (GSU) to the NRC, meeting notes, internal staff memoes and letters and telecon messages from the NRC to GSU) regarding the Technical Specifications for River Bend, Unit 1.

In the unlikely event that access and copies are denied to any part of the requested records, please describe the deleted material and specify the statutory basis for the denial as well as your reasons for believing that the alleged statutory justification applies in this instance. Also, please state separately your reasons for not invoking your discretionary powers to release the requested documents in the public interest.

I request that you waive any applicable fees as disclosure meets the statutory standard in that it would be "in the public interest because furnishing the information can be considered as primarily benefiting the general public." 5 UCS 552 (a)(4)(A). I am a landowner in the vicinity of River Bend Station and I have very closely followed this docket since early 1975.
