- SUBJECT: SUMMARY OF MEETING HELD ON MAY 19, 1988 WITH MIDDLE SOUTH UTILITIES REPRESENTATIVES TO DISCUSS PROPOSED ESTABLISHMENT AND LICENSING OF MIDDLE SOUTH UTILITIES NUCLEAR OPERATING COMPANY

On May 19, 1988, members of the NRC met with representatives of the Middle South Utilities to discuss preliminary plans and licensing arrangements for the proposed establishment of System Energy Resource, Inc. (SERI), as the operator and licensing agent for the Waterford Steam Electric Station, Unit 3 and the Arkansas Nuclear One, Units 1 & 2. SERI is presently the licensee for the Grand Gulf Nuclear Station, Units 1 and 2. The meeting participants are listed in Enclosure 1.

The SERI representatives presented an agenda for the discussions which is attached as Enclosure 2. The primary discussions involved items III D., E, and F on the proposed licensing approach. SERI has requested NRR consideration of an NRC staff team approach for a coordinated review and approval, with license amendments, of the SERI integrated submittals. NRR agreed to consider the staff team approach and to notify SERI and the licensees accordingly.

Regarding the NRC policy issues, SERI was assured that although the internal procedure for processing license amendments did not address multi-unit applications, NRR can accept and process multi-unit applications by assuring that all regulatory requirements are met on each and all dockets. It was also noted that, if literally applied, the internal amendment procedure could require a notice without a no significant hazards consideration (NSHC) determination if a review required extensive technical reviewer input. SERI was again assured that the internal policy procedure was a way to accomplish our review responsibilities but did not preclude a licensee making the appropriate NSHC, the staff reviewing the NSHC and publishing its findings, and NRR accomplishing the amendment review as best meets available resources and effective operation. If T. DAR. 5 FAC-LICthe licensee's NSHC is proper and the staff's review confirm this determination, the notice will reflect this.

- III. Proposed Licensing Approach

- A. Unique situation because of 4 OLs, 1 CP, 3 operating companies, 3 sites, and 4 NRC Project Managers
- B. No need to amend Grand Gulf OL or CP
- C. OL amendments needed for ANO-1/2 and Waterford
- D. NRC Staff team to conduct review of amendment applications, ensure uniform review of applications on similar schedules, make simultaneous no significant hazards consideration (NSHC) determinations, and authorize the amendments to be effective simultaneously and immediately
- E. NRC policy issues
 - 1. Present NRC internal OL amendment procedure does not address multi-unit applications
 - If literally applied, could require a notice without a NSHC determination
 - 3. We believe NRC review team should make NSHC determination prior to notice
 - 4. We believe immediately effectiveness warranted by nature of amendments
- F. Schedule
 - 1. Submittals per G.L. 88-06
 - a. Grand Gulf filed on May 2
 - b. ANO-1/2 to be filed
 - c. Waterford to be filed
 - Issuance of amendments to license SERI to operate ANO-1/2 and Waterford by December 1988
