In accordance with the Code of Federal Regulations, Title 10, Part 50.54(p), Carolina Power & Light Company hereby transmits four copies of the Safeguards Contingency Plan (Revision 2) and four copies of the Security Personnel Training and Qualification Plan (Revision 3) for the Brunswick Steam Electric Plant, Unit Nos. 1 and 2.

The attached documents are complete reprints of the plans and replace all previous editions. A summary of revisions for each plan is provided to assist in the review process.

The revised plans contain no changes which are known to decrease the effectiveness of the Safeguards Contingency Plan or the Security Personnel Training and Qualification Plan, nor the level of security provided.

The information attached has been designated as safeguards information and should be protected in accordance with the provisions of 10CFR73.21. It is requested that those parts of the attachments which are not protected in accordance with 10CFR73.21 be withheld from public disclosure in accordance with 10CFR2.790(d)(1).
