Background

Consumers Power Company is a party in a contested administrative proceeding before the Michigan Public Service Commission. The Attorney General of the State of Michigan (AG) is also a party. The AG has submitted testimony of Dale G. Bridenbaugh and Richard B. Hubbard, both of whom are associated with the consulting firm of MHB Technical Associates. Mr. Hubbard has identified two meetings which he had with NRC personnel concerning, in whole or part, the Midland Nuclear Plant. Mr. Bridenbaugh has identified one such meeting which he had with NRC personnel.
