Gentlemen:

This refers to the inspection conducted by Messrs. R. E. Farrell, P. W. Michaud, and A. Singh of this office during the period April 1-30, 1988, of activities authorized by NRC Operating License DPR-34 for the Fort St. Vrain Nuclear Generating Station, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included follow up of licensee action on previously identified findings, follow up of Allegation 88-A-Ol, operational safety verification, fire protection/prevention program, monthly surveillance observation, monthly maintenance observation, radiological protection, and monthly security observation. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the NRC inspectors. The inspection findings are documented in the enclosed inspection report.

Earing this inspection, it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

One unresolved item is identified in paragraph 5 of the enclosed inspection report.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 2 of the enclosed report.

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 95-511.
