On July 12-14, 1988, Laurence F. Friedman, Ph. D., C.H.P., and other representatives of the NRC and the U. S. Environmental Protection Agency (EPA) conducted an Operational Safety Review of your facility to determine whether there are potential safety hazards that, when combined with facility operations, could adversely impact upon the health and safety of the public or workers at the facility. The inspection consisted of a selective examination of procedures, processes, and representative records, interviews with personnel, and observations by members of the team.

Within the scope of this inspection, no violations of NRC requirements were identified. We are, however, concerned regarding deficiencies in the overall conduct of your non-radiological safety program, including staffing, fire protection, electrical safety, general housekeeping, storage of materials, and other areas as discussed in the enclosed report. These and other findings of the team warrant prompt management attention.

We request that you respond to this letter, describing the actions you have taken or plan relative to the observations and recommendations included in the enclosed inspection report. Further, we request that you document your actions so that the NRC and other responsible federal agencies can follow your progress in resolving these matters.

Information generated by the EPA member of the team has been incorporated into the enclosed inspection report. Therefore, it is our understanding that the EPA does not plan to issue a separate report concerning this inspection.
