As you are aware, the NRC is in the process of forming its final views regarding the readiness of Boston Edison to return the Pilgrim facility to operation. As part of that process, Region I recently completed an Integrated Assessment Team Inspection (IATI) in late August, the Advisory Committee on Reactor Safeguards has reviewed the readiness of Pilgrim and the NRC is holding a local public meeting in Plymouth on September 29, 1988 to review the proposed restart.

The Director of Nuclear Reactor Regulation, Dr. Thomas E. Murley, has scheduled a public meeting in Rockville on October 5, 1988 to further discuss the readiness status of Pilgrim.
