Gentlemen:

The staff of the Uranium Recovery Field Office has reviewed a request from Western Nuclear, Inc. (WNI) dated December 11, 1985 for transfer of Source Material License SUA-1337 to Malapai Resources Company (MRC). Additionally, the Uranium Recovery Field is in receipt of your request for license transfer dated December 30, 1985, and has reviewed the mining permit issued by the Wyoming Department of Environmental Quality for operation of the Willow Creek R&D in situ leach facility located in Campbell County, Wyoming. By accepting the transfer of this license, MRC assumes all liabilities implied therein. Therefore, pursuant to Title 10, Code of Federal Regulations, Part 40, and in accordance with the above-cited submittals, Source Material License SUA-1337 is hereby transferred from WNI to MRC. License Condition Nos. 1 and 2 are revised to read as follows:
