Physical Security Plan NUREG 0908 Upgrade

Submittal Under 10 CFR 50.54 (p)

Florida Power and Light Company has recently completed a rewrite of the current plan to conform with the guidance provided in NUREG 0908, Acceptance Criteria For The Evaluation of Nuclear Power Reactor Security Plans. This upgraded plan is current to revision 13 of the Turkey Point Physical Security Plan (PSP) and has been determined by FPL to not decrease the safeguard effectiveness of the plan.

Due to the significant format change and the number of changes in procedures and related documents that are required by the new format, this upgraded plan will be implemented effective August 31, 1988. Any changes that occur to the controlling PSP before the effective date of the upgraded plan will be incorporated in the upgraded plan prior to its implementation. An explanation of these changes and revised pages will be submitted under the next sequential revision number pursuant to the requirement of 10 CFR 50.54 (p). This method of submittal and the status and content of the upgraded plan have been discussed with the Region II staff at a March 15, 1988 meeting in Atlanta and a subsequent telephone conversation on May 18, 1988.

Pursuant to 10 CFR 50.54 (p), an explanation of the changes and three copies of the upgraded plan are enclosed.
