SUMMARY OF
PROPOSED CHANGES

SUMMARY OF PROPOSED CHANGES

I. Specification AC 7.1.1. is reformatted to better conform to the Standard Technical Specifications' (STS) format, revised to include the new titles of the recent Fort St. Vrain (FSV) reorganization, and follows the guidance of Generic Letter 88-06 to allow deletion of the organization charts and reference to them. Specific changes include:

- Section 1- "RESPONSIBILITY" section added delegating control room command responsibility and corporate responsibility for overall plant nuclear safety per STS guidelines.
- Section 2a- "Onsite and Offsite Organization" section added to provide a directive for the establishment and definition of lines of authority, responsibility, and communication for onsite and offsite organizations per Generic Letter 88-06 guidelines.
- Section 2b(1)- Designates on-duty shift minimum shift crew composition per Table 7.1-1, following Generic Letter 88-06 guidelines. This section also incorporates current Section 2.a requirements.
- Sections 2b(2,3,4)- Discuss licensed operator on-shift requirements. This section includes part of the current clarification text following Table 7.1-1, and the requirements of current Section 2.b.
- Section 2b(5)- Discusses core alteration supervision, incorporating the requirements of current Section 2.c, with minor editorial corrections.
- Section 2b(6)- Discusses the onsite requirements for a radiation protection qualified person, incorporating the requirements of current Section 2.d.

Section 2b(7)&
Fire Brigade Note- Discuss the site Fire Brigade, incorporating the requirements of current Section 2.e and its Note, with minor editorial corrections.

Sections 2b(8, 8a
through 8d)- Discuss staff working hours, incorporating the requirements of current Sections 2.i and 2.i(1 through 4), with minor editorial corrections.

Section 2b(9)- Discusses deviation of working hour guidelines, incorporating the requirements of the paragraph following current Section 2.i(4), and the position titles of the FSV reorganization.

Section 2b(10)- Section added to delineate those requiring a Senior Reactor Operator's (SRO) license and those requiring a Reactor Operator's (RO) license per the guidelines of Generic Letter 88-06, Section 6.2.2.g.

Section 2b(11)- Discusses shift crew composition, incorporating, with minor editorial corrections, the requirements of the current final clarification paragraph following Table 7.1-1, which were not included in the proposed Sections 2.b(2,3,4).

Section 2b(12)- Added to delineate control room command responsibility in the absence of the Shift Supervisor, and further expounds on proposed Section 1.b.

Table 7.1-1- Placed within Specification AC 7.1.1 following Section 2. Editorial corrections are made to conform with this proposed amendment's formatting.

Section 3- "TECHNICAL ADVISORS" section is added and centralizes discussion of the function, responsibilities, and authority of the Technical Advisors. This section incorporates the requirements of current Sections 1.c and 2.f. Revisions are made in formatting, and position titles due to the FSV reorganization.

Section 4-

"UNIT STAFF QUALIFICATIONS" section is added and discusses staffing and qualification requirements; and incorporates the requirements of current Sections 2.g and 2.h, with editorial corrections.

Section 5-

"TRAINING" section was reformatted as Section 5 and contains editorial corrections. This section incorporates requirements of current Section 3.

II. Specification AC 7.1.2 is revised as follows:

Section 1-

The Plant Operations Review Committee (PORC) "Membership" section is revised to incorporate position titles of the FSV reorganization:

-Current Technical/Administrative Services Manager is replaced by the Nuclear Support Manager;

-Current Support Services Manager is replaced by the Superintendent of Chemistry and Radiation Protection (Radiation Protection Manager);

-Current Superintendent of Maintenance is replaced by the Maintenance Department Manager;

-Current Superintendent of Nuclear Betterment Engineering and Superintendent of Technical Services Engineering are replaced by the Systems Engineering Manager;

-Current Results Engineering Supervisor is replaced by the Superintendent of Instrumentation and Controls (I&C) Maintenance;

-The new position of Operations Manager is created by the reorganization; and the current position of Administrative Shift Supervisor is deleted by the reorganization.

Sections 5a, 5e, 6d, and j-

These sections are revised to incorporate new position titles of the FSV reorganization.

Section 5k-

PORC "Review of every unplanned onsite release of radioactive material to the environs..." is deleted. This requirement is adequately covered in Sections 5.a through 5.g.

III. Specification AC 7.1.3. is revised as follows:

- Section 1- Formatting changes only are made.
- Section 2- The Nuclear Facility Safety Committee (NFSC) "Membership" is revised to incorporate new position titles of the FSV reorganization.
- Sections 3,4, and 9- "Vice President, Nuclear Operations" is revised to be "Senior Vice President, Nuclear Operations".
- Section 10a- Revised to delete the requirement that each NFSC meeting's minutes be approved within 30 days following each meeting.
- Section 10b- This section was added and directs the preliminary approval of the NFSC meeting minutes by the Senior Vice President, Nuclear Operations. It also directs the distribution of the minutes to the NFSC members, and approval of the minutes at the next NFSC meeting.
- Sections 10c and 10d- Reformatted, and revised to incorporate the new title of Senior Vice President Nuclear Operations.

IV. Pages 7.1-20 through 7.1-23 are deleted:

- Pages 7.1-20 & 7.1-21- These pages are deleted. They contain Table 7.1-1, and its associated notes and clarification information. This information is now included elsewhere in this proposed amendment formatting.
- Pages 7.1-22 & 7.1-23- These pages contain the organization charts (Figures 7.1-1 and 7.1-2), and are deleted following the guidelines of Generic Letter 88-06.

V. Specification AC 7.2 is revised as follows:

- Sections b. and d.- "Manager Nuclear Production" is revised to be "Manager, Nuclear Production and Station Manager."
