Dear Sir,

This is a request under the Freedom of Information Act, as amended, for all documents pertaining to the following:

- (1) correspondence between the NRC and Automatic Sprinkler Corporation of America (ASCOA) about the operability of 6-inch deluge and pre-action fire protection water control valves;
- (2) licensees notified by ASCOA about the valves, licensees affected by the inoperability of the valves;
- (3) ASCOA instructions for both temporary and permanent solutions to problems associated with the operability of the valves for use by licensees;
- (4) NRC efforts to assure licensee compliance with requirement for operable sprinkler system i.e. enforcement efforts, follow up investigations.

The information being requested will be used by interested members of the public and will be brought to the attention of members of Congress, NRC Commissioners and other state and local officials. Because no personal financial benefit will ensue, I hereby request waiver of the search and copy costs.
