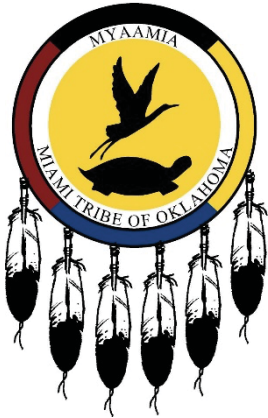

Aya, kikwehsitoole – I show you respect. My name is Diane Hunter, and I am the Tribal Historic Preservation Officer for the Federally Recognized Miami Tribe of Oklahoma.

The Miami Tribe offers no objection to the above-referenced project. We support and emphasize the statement, “Consultation required by Section 106 of the National Historic Preservation Act ... will be conducted and included in the Supplemental EIS for each application and will not be part of the ANR Generic EIS.”

If any human remains or Native American cultural items falling under the Native American Graves Protection and Repatriation Act (NAGPRA) or archaeological evidence is discovered during any Advanced Nuclear Reactor project within the areas of interest of the Miami Tribe, we request immediate consultation with the entity of jurisdiction for the location of discovery.
