Siva,

We met with our emergency planning organization this afternoon to discuss the implementation strategy for our emergency plan staffing licensing amendment request. A requested implementation date of 6 months from the issuance of the amendment was based on standard 1 year review with the staff and took into account emergency plan activities occurring in the first half of 2020, including a full scale dress rehearsal and an evaluated exercise.

Based on our conversations, I understand the staff is expecting to issue the license several months early. This does affect our original plan to implement this LAR in the second quarter of 2021.

Therefore, we would like to change our requested implementation date from 6 months from issuance of the LAR to June 30, 2021.
