Dear Ms. Kouretas:

This is in reference to your response to NRC Request for Additional Information and revised Decommissioning Plan (DP), letter received February 27, 2020, (Agencywide Documents Access and Management System (ADAMS) Accession Number ML20063M403), and letter, dated, August 6, 2019, (ADAMS Accession Number ML19219A924), requesting to amend NRC License No. SUB-348.

During our review, we identified additional deficiencies that need to be addressed before we can accept the revised plan and amend your license.

In order to continue our review, we need the following additional information:

- 1. Please explain how the building surface and soil area factors were calculated. It appears that the factors are a combination of an area factor and a conversion of the Derived Concentration Guideline Levels to meet New Jersey's release criteria of 15 mrem/year.
- 2. Please explain how the length parallel to aquifer flow was determined. Please insert a table to describe any differences from the default parameters.

We will continue our review upon receipt of this information. Please reply to my attention at:
