The license condition refers to three dates that are responses to requests for additional information (RAI). The NRC technical evaluation for the SDP refers to four responses to RAIs, with the last one on July 25, 2006, being the one not mentioned in the License. The July 25, 2006, doc has an attachment titled Appendix E, Consolidated Soil Plan. Furthermore, the 2006 SDP mentions the NRC requests for additional information (RAI) by date; these match up with the RAI dates in the Technical Evaluation Report, except for the Oct 27, 2005 public meeting items.
